Dart Update-

Discussion of where the proceeds from the annual raffle/auction should go to, if decided to do so again, was brought up. Talks of the proceeds going to a group/charity of the board's decision was an option. Then Sarah Tunge suggested that maybe the proceeds from the raffle/auction could be tied-in with the Scholarships, instead of trying to figure out which group or charity would receive it. *Motion made by Sarah Tunge to use the proceeds made from the annual NDCDEA raffle/auction towards the NDCDEA Scholarships as presented. Tokina Mcharry seconded the motion. Motion passed unanimously.*

NDASCD-

Dustin meets with the NDASCD on Monday, December 13th for their meeting. After discussing with the other directors, Dustin is going to ask the Association where they see the partnership with the NDCDEA going and how do we increase funding opportunities.

Conservation Collaborative Grant (also called the 'Partnership Collaborative Grant')-

Sarah Tunge said there are opportunities and funding available and will be letting everyone know more within the next couple of weeks. Sarah is also working on getting some other partnerships involved with the project that we can work with.

Northern Plains Regional Representative/NACD-Sarah Tunge-

Sarah was in Montana for their meeting, and she said that they hold a monthly call-in meeting with their SCDs, discussing a variety of topics. They roughly hold eleven meetings/calls per year, and it seems to be a great success within the State. Sarah would like to throw that idea out to our Districts and see if it's something that would go over well and if there would be good participation rates. As the Northern Plains Regional Representative for the NACD, Sarah asked to stay on the NDCDEA board as an

advisor, since her elected term will expire at tomorrow's NDCDEA business meeting. The other directors agreed, so Sarah Tunge will serve as an advisor to the NDCDEA board, along with Rhonda Kelsch.

Other Business:

James River SCD/Dickey County-

Tokina Mcharry brought to the board's attention that she, along with the James River SCD (Dickey County) board of supervisors, will be going to the NDASCD board on Monday, December 13th to hand-in their proposal to purchase Oakes Nursery from the NDASCD. The plans for James River SCD are to utilize the Oakes Nursery, with its unique sandy soils, for educational and research purposes. *Motion made by Sarah Tunge to have a letter of support written on behalf of the NDCDEA for James River SCD (Dickey County) to purchase Oakes Nursery as presented. Ryan Thorson seconded the motion. Motion passed unanimously.*

With no further business to discuss, Ryan Thorson motioned to adjourn the meeting. Tokina Mcharry seconded the motion. Meeting adjourned.
